

Accident Waiver and Release of Liability, Name and Likeness

I certify that I am physically fit, have sufficiently trained and prepared for participation in the Virtual Double Century (referred to herein as "Virtual DC"), and have not been advised otherwise by a qualified medical person. I acknowledge that Virtual DC is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, temperature, weather, condition of athletes, lack of hydration, infectious disease, equipment, vehicular traffic, and actions of other people including participants. The risks are not only inherent to participants, but are also present for private SAG. I hereby assume all of the risks of participating and/or volunteering for Virtual DC.

In consideration of my application and permitting me to participate in Virtual DC, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, disease, property damage, property theft or actions of any kind which may hereafter accrue to me during or my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: Planet Ultra Inc. and California Triple Crown Inc. and each of their directors, officers, employees, volunteers, representatives, owners, and agents, the event holders, sponsors, directors, volunteers, as well as any and all involved municipalities or other public entities and their respective agents and employees; (B) Indemnify and Hold Harmless the entities and persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of any of my actions during this Virtual DC.

I have read, understand, and agree to abide by the rules of the Virtual DC as published on the Planet Ultra website. I agree to investigate the existence of and to abide by any and all COVID-19 restrictions that may be in place in any jurisdiction I choose to ride. I also understand that I am 100% responsible for my route choice, for recording my ride with a GPS unit and uploading the ride to Strava within 48 hours of completion. If my route does not meet qualifying standards or if I do not upload to Strava on time, I take full responsibility and understand that I will not receive California Triple Crown credit for the event.

I understand there are no refunds for any reason, including but not limited to failure to receive CTC credit due to CTC rule violations.

I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by Virtual DC holders, sponsors, and organizers, for all aspects of the Virtual DC, and that it will govern my actions and responsibilities during the Virtual DC. It is further understood and agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. This AWRL shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
