



## Accident Waiver and Release of Liability, Name and Likeness

The risks are not only inherent to participants, but are also present for private SAG. I hereby assume all of the risks of participating and/or volunteering in this Challenge.

In consideration of my application and permitting me to participate in this Challenge, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, disease, property damage, property theft or actions of any kind which may hereafter accrue to me during or my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: Planet Ultra Inc. and its directors, officers, employees, volunteers, representatives, owners, and agents, the event holders, Challenge sponsors, Challenge directors, Challenge volunteers, as well as any and all involved municipalities or other public entities and their respective agents and employees; (B) Indemnify and Hold Harmless the entities and persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of any of my actions during this Challenge.
